# REGULATION

## INTRODUCTION

Since two years, the whole of humanity has been subjected to severe and unimaginable restrictions because of Sars Cov 2. The cultural, artistic and musical sector is certainly paying the highest price. Hence the commitment of A.Gi.Mus. to create valid alternatives aimed at encouraging and stimulating the many young and talented musicians who, very often, in such discomfort, find themselves deprived of the aims and objectives necessary to continue their artistic and musical training.

## ART. 1 - ORGANIZATION AND PURPOSE

The 2nd European Online Section of Francavilla Fontana - and aims to promote, today more than ever, musical culture, musical institutions and, above all, musicians. This Competition is under the patronage of MIUR - Ministry of Education, University and Scientific Research - and MIBACT - Ministry of Artistic, Cultural and Tourism Heritage, and is organised with the collaboration of SOAVEGEL and AGIC TECHNOLOGY, virtuous companies from Francavilla Fontana of international importance.

A.GI.MUS. - Musical Youth Association is accredited to the F.U.S. (Fondo Unico della Spettacolo) established by the MIBACT - Ministry of Artistic, Cultural and Tourist Heritage. Ministry of Artistic and Cultural Heritage and Tourism. Piano Competition "Salentinae Terrae" is organized by A.GI.MUS. - Musical Youth Association -

## ART. 2 - METHOD OF CONDUCT

The 2nd European Online Piano Competition "Salentinae Terrae", due to the persistent health emergency from Covid-19, will be held in telematic mode, that is, competitors will have to send an audio-video recording of their performance in mp4 format, containing their participation programme, according to the procedures that will be explained below. The Commission, starting from 28th February 2022, will begin its listening and evaluation work, which will presumably be completed by 6th March 2022. The results will be announced through the publication of a video clip, for which the competitors will be subsequently given precise instructions. The certificates will be sent in digital format by email.

## ART. 3 - REGISTRATION

Applications for registration to the 1st European Online Piano Competition "Salentinae Terrae" must be sent no later than MONDAY 14nd FEBRUARY 2022, by filling in an online form specially prepared on the official website of the competition, at the following address [www .agimusfrancavilla.com](http://www.agimusfrancavilla.com). While, the video files of the performances can also be sent later, in any case no later than the date of Sunday 20th February 2022.

## ART. 4 – CATEGORIES

Category "FIRST NOTES"	for those born from 2015	- maximum duration of the test: 5 min.
Category "A"	for those born in 2012-2013-2014	- maximum duration of the test: 7 min.
Category "B"	for those born in 2009-2010-2011	- maximum duration of the test: 10 min.
Category "C"	for those born in 2006-2007-2008	- maximum duration of the test: 15 min.
Category "D"	for those born in 2003-2004-2005	- maximum duration of the test: 18 min.
Category "E"	for those born in 2000-2001-2002	- maximum duration of the test: 20 min.
Category "F"	for those born in 1997- 1998-1999	- maximum duration of the test: 25 min.
Category "G"	for those born up to 1996 without age limits	- maximum duration of the test: 30 min.

### **ART. 6 - PROGRAMS**

The execution program is free and, therefore, at the sole choice of the candidate.

### **ART. 7 - INSTRUCTIONS FOR THE MAKING OF THE VIDEO EXECUTION AND SUBMISSION METHOD**

The Candidate is required to make a video recording of his / her competition program, taking care to produce a file for each piece he intends to submit to the Competition. It should be noted that the file must be saved in MP4 format.

Furthermore, the Candidate must comply with the following indications:

- A) Respect the time limit set in their category;
- B) Do not make cuts and / or audio-video manipulations;
- C) The shot to be used during registration must be lateral, allow the candidate to be recognized and make the upper and lower limbs visible, as shown in the image at the end of this regulation;
- D) Each file must report in the name:
  - 1. CATEGORY;
  - 2. SURNAME AND NAME;
  - 3. NAME OF THE SONG AUTHOR;
  - 4. SONG TITLE;
- E) The Candidate must create and send a video file for each piece to be presented in the competition;
- F) Finally, the video or videos must be sent using the WE TRANSFER service ([www.wetransfer.com](http://www.wetransfer.com)) on Internet, with which it will be possible to easily and conveniently transfer large files, as long as the total for each sending does not exceed 2GB. Beyond this limit you will have to proceed with more mailings.

### **ART. 8**

Registration fees are in no case refundable, unless the competition is canceled.

In this case, the registration fees will be fully refunded.

### **ART. 9 – COMMISSIONS**

The Commission will be made up of musicians and teachers (including foreigners) of clear fame and proven experience.

### **ART. 10 - AWARDS**

- 1st Absolute Prize: The competitor who achieves the mark of 100/100 will receive the 1st Absolute Prize Diploma.
  - 1st Prize: The competitor who has achieved a mark between 95/100 and 99/100 will receive the 1st Prize Diploma.
  - 2nd Prize: The competitor who has achieved a mark between 90/100 and 94/100 will receive the 2nd Prize Diploma.
  - 3rd Prize: The competitor who has obtained a mark between 85/100 and 89/100 will receive the 3rd Prize Diploma.
- The competitor who has obtained a mark lower than 85/100 will receive a Certificate of Participation.

### **Awarding of Prize Concerts**

At the end of the competition the commission may assign to those competitors (both soloists and formations) who have particularly distinguished themselves, on its own unquestionable indication, up to n. 6 concerts, to be held as part of the 2022 and 2023 Artistic Season of the A.Gi.Mus - Francavilla Fontana Section.

### **ART. 11**

All Competition proofs may be broadcast by radio and television broadcasters, or published on social platforms, without entailing the right to compensation.

### **ART. 12**

In case of need, the Organizers reserve the right to make changes to these regulations. In this case the competitors will be promptly informed.

### **ART. 13**

Communications, news and information pertaining to the competition in question must be obtained only and exclusively through the official channels of the competition itself, the details of which are given:

- 04) An online form will be opened that must be completed and to which you will have to attach files of the IDENTITY DOCUMENT and the BANK TRANSFER RECEIPT.
- 05) Proceed, therefore, with the sending of the registration.
- 06) The sending of video files (in MP4 format) can be made at the time of submission of the application, or subsequently, as long as it takes place without exception by Sunday, February 20th, 2022.
- 07) Remember that the video files must be named with CATEGORY - FIRST AND LAST NAME - AUTHOR OF THE SONG - TITLE OF THE SONG.
- 08) Address yourself on the website [www.wetransfer.com](http://www.wetransfer.com).
- 09) Enter the sender's email address, the recipient's email address ([agimusfrancavilla@gmail.com](mailto:agimusfrancavilla@gmail.com)), upload the files and proceed with the sending. Sending files via We Transfer will be successful as long as you do not exceed 2GB. If this limit is exceeded, it is necessary to proceed with another send.
